# PRESIDENT'S REPORT

# Dear UNAAWA members, friends and family,

To be part of and to serve the UNAAWA gives me much pride and satisfaction. I often say to others, the standout feature that distinguishes the UNAAWA is the spirit of altruism, goodwill and common purpose in our members. I see this quality clearly in our volunteers who serve selflessly, putting in much effort and sacrificing much of their own time to advance our mission.

To all the volunteers, committee members and executives of the UNAAWA, I give heartfelt thanks to each and every one of you for all the time and effort you have given and continue to give to the UNAAWA. You are what makes the UNAAWA run. Without your support or that of our many sponsors and members, none of what we have done would have occurred. To all UNAAWA volunteers, I am always grateful to work together with you and learn from you.

To our executive team, it is and remains a privilege to serve alongside you, to have your support and I will always continue to support each of you in any way I can.

Over this past year, 2024-25, we have continued to grow, and our organisation is stronger today, with stronger financial reserves and an executive team committed to delivering for our members.

We have increased engagement with local government authorities and are working to expand partnerships with them. The aim is to extend our reach to more people to raise awareness of the UN mission. We aim to promote our events and encourage attendance at our events, and in return to promote their events amongst our members and raise awareness of everyone as to the good work these authorities are doing. We are currently working to reach an arrangement with the WA Local Government Association (WALGA) which will have an impact across all local governments for the benefit of society in Western Australia.

The UNAAWA has 5 committees which are the driving force of its activities, namely the Human Rights committee, the Environment committee, Gender Equality committee, the Sustainable Development Goals (SDG) committee and the Young Professionals committee continue to work and run events. These events make an impact and raise awareness within their specialist mandate in Western Australia. The events our committees have run have not only spread awareness and raised the profile of the UN mission, but they have also inspired others, encouraged connections and are models to follow to raise awareness of the UN goals to make our world a better place. With these aims, the UNAAWA has continued in its mission.

Our biggest event of the year is ahead, namely our UN Day Gala, where we will celebrate our milestone 80<sup>th</sup> Anniversary of the United Nations on 17 October 2024 at the Duxton Hotel. At the UN Day Gala, we will welcome state leaders, consuls, industry figures, community champions and committed individuals. We can look forward to coming together on that day to celebrate the values of global solidarity with a sense of hope, upon which the UNAAWA was founded, and to remind ourselves we are united by more than what divides us.

# FINANCIAL OUTLOOK

# **BALANCE SHEET, TOTAL EQUITY**

On the financial front, I am pleased to announce that the UNAAWA has continued to manage our financial resources with diligence. UNAAWA has continued to stay financially solvent, and that we have managed to grow our fundraising through efforts by committee convenors and members. I wish to commend the professionalism of our Treasurer, our Deputy Treasurer and our Assistant Treasurer and all those who contributed for ensuring the long-term sustained financial health of our organisation.


As of 30 June 2025, the organisation's total net assets stand at \$84,182 compared to \$84,839 in 2024) which is a 0.77% decrease over the previous financial year. The organisation recorded a modest net deficit of \$656 in current year earnings for 2025, compared with a surplus of \$7,372 in 2024. The Women's Grant for a Stronger Future income was received in 2024 and under accounting standards the UNAAWA operates under, the income had to be recognised immediately upon receipt of the grant, even though the related expenses incurred in 2025. The reduction shown in current year earnings is therefore understandable, and not an indication of the overall finances of the organisation.

The UNAAWA is financially solvent and remains an accountable and responsible steward of the funds received. The Treasurer has taken steps to invest our reserves strategically, and we have placed \$50,000 of UNAAWA funds into term deposits for an increased rate of return, to further strengthen our financial sustainability and support our ongoing initiatives.

The UNAAWA's most important source of income remains the Association's membership fees and fundraising events, including but not limited to the UN Day Gala, the SDG Business Forums, the Members networking events, including all activities organised by the Young Professionals, Environment, SDG, Gender Equality and Human Rights committees.



#### Income FY 2025



Our financial position and membership base enhances our financial position and enables us to reinvest in our programs and mission. We recognise the hard work of our dedicated volunteers, members and convenors who have collectively enabled the UNAAWA to obtain sponsorships and other sources.

#### **MEMBERSHIP**

I am happy to report we have had an increase in membership from 145 to 158 over the past year. Of interest is that the categories of membership are showing shifts. There are, for example, greater numbers of concession memberships and Young Professionals joining, and a reduction in Ordinary 1-year membership. We welcome all new members in all categories of memberships, and we look to grow these numbers further with more membership events.

The distribution of memberships remains consistent with the previous financial year, with the most popular membership category remaining the 1-year Ordinary type (43), followed by the 1-year Concession type (34). The membership as of 30 June 2025 numbers 158 compared to 145 in 2022, but Organisational 1–3-year membership (includes corporates, governments, and universities) has gone down from 5 to 4 this past year. Member's Ordinary 3-year membership has also increased from 10 to 20, with Young Professionals membership numbers increasing from 3 in 2023, to 22 in 2024 and 30 in 2025.

# Nature's Symphony International Art Exhibition – May 2025

In collaboration with the WA Zhejiang Association and The Lantern Collective, UNAAWA cohosted the inaugural Nature's Symphony International Art Exhibition at the historic Perth Town Hall. The exhibition ran for four days and was proudly supported by the Office of Multicultural Interests, the City of Perth, and over 15 local and international art studios and associations.

This initiative aligned with the following Sustainable Development Goals:

- Goal 11 Sustainable Cities & Communities
- Goal 13 Climate Actions
- Goal 14 Life below Water
- Goal 15 Life on Land







# Key highlights:

- Over 70 artists from Australia and overseas presented works reflecting interconnectedness of nature, culture, and sustainability.
- A special address was delivered by renowned Noongar artist Sharyn Egan, who shared her artistic inspiration and deep cultural connection to Country.
- Two workshops on Arts and Leadership engaged 30+ students, empowering young people to connect creativity with responsibility.
- The exhibition welcomed 2,000+ guests over four days, attracting families, professionals, and youth.

The event amplified public awareness of environmental protection, fostered cross-cultural dialogue, and highlighted the role of arts in advancing sustainability.

In addition to major events, I represented UNAAWA at various multicultural and civic activities, strengthening our presence and visibility. These engagements allowed us to:

- Build new partnerships across government, business, and civil society.

# **COMMITTEE REPORTS**

# **ENVIRONMENT COMMITTEE**

The 2024–2025 reporting period was a transitional year for the Environment Committee (EC) as I stepped into the role of Convenor and have since concentrated on strengthening membership, engaging more volunteers, and delivering meaningful events that align with environmental priorities within the SDGs.



The UNAA(WA) Environment Committee has been focusing this year on growing our membership and creating a firm base from which we can engage, inspire and inform the wider community through high-profile and high-impact events.

This year, the UNAA WA Environment Committee successfully hosted a Circular Economy Event on 4th September, held at the sustainable building Boola Katijin at Murdoch University. The event included presentations and panel discussion with industry leaders, academics and Government professionals, who shared their lived and professional experience on the role of circular economy – millennia old concept. Their insights highlighted practical every-day advice for reducing waste as well as broader sector-wide strategies for engaging people in promoting resource efficiency.



A dynamic panel discussion followed, exploring opportunities and challenges specific to Australia's transition to circularity. A highlight of the event was the engaging Q&A session where the audience, and especially students actively took part in the discussion. It was heart-warming to see the level of engagement that this much-needed discussion on circular economy brought.





The event was well received, with participants commending the relevance of the topic and the quality of discussion. It reinforced the UNAAWA Environment Committee's commitment to promoting the UN Sustainable Development Goals (SDGs) and creating platforms for dialogue on innovative sustainability practices.

Looking ahead, the UNAAWA Environment Committee is planning to celebrate the UN Environment Day on the 5<sup>th</sup> June 2026 and to continue to engage in collaborative efforts to promote sustainable development in Western Australia.

# **HUMAN RIGHTS COMMITTEE**

The 2024–2025 reporting period marked a pivotal year of transition for the UNAA WA Human Rights Committee. During this time, we deepened our engagement with the Sustainable Development Goals (SDGs), while exploring pressing local concerns, initiatives, and organisations across Western Australia. Our focus was on laying a strong foundation to support future initiatives and events that deserve greater visibility, recognition, and impact.













The Committee's work aligns with the following SDG goals and targets:

- **Goal 1: No Poverty** Ending poverty in all its forms remains central to our efforts. Addressing homelessness is a key priority, as it is both a cause and consequence of poverty.
- **Goal 3: Good Health and Well-being** Recognising the health impacts of homelessness, we support improved access to physical and mental healthcare.
- **Goal 4: Quality Education** Emphasising education as a pathway out of homelessness and inequality, advocating for accessible and inclusive learning opportunities.
- **Goal 10: Reduced Inequalities** We advocate for inclusive policies and practices that empower marginalised groups, including those experiencing homelessness.
- Goal 11: Sustainable Cities and Communities initiatives promote inclusive urban development and access to affordable housing for all.
- **Goal 16: Peace, Justice, and Strong Institutions** Seeking to address systemic barriers to justice and promote inclusive, equitable institutions.

#### **KEY IMPACTS**

Strengthened engagement with National Reconciliation WA through deeper learning and support initiatives. Supported the screening of Destiny Rescue's award-winning anti-trafficking documentary, Operation Goldilocks, highlighting the prevalence of child exploitation and the increasing risks of online abuse.

- SDG Target 5.2: Eliminate all forms of violence against women and girls, including trafficking and exploitation.
- SDG Target 8.7: Eradicate forced labour, end modern slavery and human trafficking, and eliminate the worst forms of child labour.
- SDG Target 16.2: End abuse, exploitation, trafficking, and all forms of violence against children.





In addition to promoting community engagement, volunteerism, and awareness of human rights issues at local levels, the committee has also supported the UN Day Human Rights Awards, recognising outstanding contributions to the promotion and protection of human rights in alignment with the UN Sustainable Development Goals.

## **Why Our Work Matters**

The UNAA WA Human Rights Committee plays a vital role in fostering awareness, advocacy, and action on human rights issues that affect both local and international communities. Our work is grounded in the belief that meaningful change begins with informed engagement and inclusive dialogue.

#### **FUTURE INITIATIVES & OUTLOOK**

- Exploring the role of the private sector in addressing modern-day slavery, including potential collaboration with Destiny Rescue and the Australia International Counter-Slavery Alliance (AICSA).
- Walk for Reconciliation 30 October 2025 at Galup (Lake Monger), featuring Welcome to Country, key speakers, song, and Smoking Ceremony to promote truth and healing.
- International Human Rights Day 10 December 2025: Raising awareness of human rights challenges and amplifying the voices of marginalized communities through meaningful dialogue and advocacy.

# **GENDER EQUALITY COMMITTEE**



The reporting period of 2024–2025 has been a transformative year for the Gender Equality Committee (GEC). This year, our efforts have been dedicated to advancing gender equality and empowering women and girls through leadership development programs, community engagement initiatives, and strong partnerships. The GEC remains committed to the power of collaboration in advancing Sustainable Development Goal (SDG) 5: Achieve gender equality and empower all women and girls.

The following customised SDG 5 targets guide our work:

- Target 5.1 Build resilience mindsets for girls while actively supporting and monitoring their mental health.
- Target 5.5 Ensure women's full and effective participation and equal opportunities for leadership at all levels, with emphasis on education, STEM skills, and financial literacy to prepare girls and women for future opportunities.
- In 2024–2025, the GEC made meaningful strides in creating spaces for connection, education, and empowerment, building on the momentum of past years while launching new initiatives. Key highlights include:

# Young Women's Leadership Program (Metropolitan)

This year's journey began with a powerful two-day Young Women's Leadership Program (YWLP) in the Perth metropolitan area. As the new GEC convenor, I am deeply proud of the incredible branch of women leaders who helped deliver and develop this inspiring program for 2025. We are especially grateful to our speakers, who generously shared their time, expertise, and stories to empower the next generation of women leaders.









# **Community STEM & Drone Discovery Day**

In August, we proudly supported the STEM & Drone Discovery Day at Murdoch University, bringing together students, families, educators, and technology professionals for a free, family-friendly celebration of innovation. The day featured a youth drone tournament, indoor drone light shows, a tech and AI panel, interactive workshops, and exciting demonstrations, helping to spark curiosity and confidence in STEM pathways for young women and girls.



# Young Women's Leadership Program (Regional)

This September, the GEC extended its reach to regional and indigenous communities, hosting the Young Women's Leadership Program in Bunbury for young women in Year Levels 10–12. This program offered workshops and discussions on leadership, gender equality, financial literacy, and artificial intelligence, providing regional youth with access to mentors, role models, and resources to thrive.







These initiatives reflect our mission to strengthen pathways for young women to lead and succeed in their communities, regardless of location or background. Through the commitment of our committee members, speakers, and partners, the GEC continues to amplify voices, create opportunities, and contribute to a future where all women and girls can flourish.

#### **Mid-Autumn Festival Booth**

The Gender Equality Committee proudly supported the inaugural Mid-Autumn Festival at St Hilda's Anglican School for Girls, a shining example of cultural celebration and community spirit. With the generosity of families, partners, academies, and volunteers, the event fostered harmony, belonging, and intercultural understanding—values that reflect UNAAWA's mission and strengthened connections with diverse multicultural communities.

# SDG BUSINESS FORUM SERIES COMMITTEE





The UNAAWA organised four SDG Forums in the past 12 months. The Forums were titled "Driving SDG Progress: Public Sector Innovations" sponsored by Murdoch University; "Path to 2030: Youth Fireside Chat on Education, Careers, and the UN SDGs" in partnership with the University of Western Australia's Australia-China Youth Association; "Gross National Happiness & the Future of Sustainable Development" sponsored by EY Perth, and "Stronger Together: Connecting & Belonging through Sports" hosted at the West Coast Eagles' Mineral Resource Park. An upcoming Forum will be held in November sponsored by Curtin University titled "AI for Good & Achieving the SDGs".

# **SDG Forum 1: Driving SDG Progress: Public Sector Innovations**

An SDG Business Forum was held on 30 October 2024 at The Platform, Perth, focusing on how public sector innovation can accelerate progress towards the Sustainable Development Goals. Opened by Hon. Klara Andric MLC, representing Minister Dawson, highlighted the Cook Government's commitment to innovation through initiatives such as the WA Public Sector Innovation Network, and the use of AI and digital infrastructure to deliver inclusive solutions. Speakers included Assoc. Professor Martin Brueckner of Murdoch University, who outlined the university's sustainability strategy, and a panel of experts from Department of JTSI, EY, Microsoft, and Murdoch University. Discussions explored overcoming barriers to innovation, leveraging AI, strengthening evidence-based decision-making, and building effective partnerships. Key themes underscored the need for cultural change, advocacy, and systemic collaboration across government, business, and communities to deliver a sustainable and equitable future.







# SDG Forum 2: Path to 2030: Youth Fireside Chat on Education, Careers, and the UN SDGs

Held at UWA, the event gathered young professionals, students, and educators to explore how youth can shape a sustainable, inclusive future through innovation and cross-sector collaboration. The panel unpacked the growing need for partnerships between academia, industry, and youth organisations to address education and employment challenges. Speakers stressed that "profit and purpose can co-exist," urging businesses—particularly SMEs—to integrate SDGs through innovation, incentives, and long-term impact thinking. The role of soft skills like adaptability, empathy, and critical thinking was highlighted as key in preparing youth for an uncertain job market. One speaker noted, "We need to empower students not just with degrees, but with the mindset to lead change." The call to action at the forum was to localise global goals and create inclusive spaces for diverse youth voices in leadership.



# SDG Forum 3: Gross National Happiness & the Future of Sustainable Development

Over 100 changemakers, students, public servants, and professionals gathered at EY Perth on 6 June 2024 for the SDG Forum, sponsored by EY Perth. The event examined alternatives to traditional economic measures, showcasing Bhutan's Gross National Happiness (GNH) Index as a model of progress centred on well-being, sustainability, and community. The evening opened with Bhutanese filmmaker and environmental advocate Jamyang Jamtsho Wangchuk, who shared his "Messenger – Ride for Action" campaign, carrying Himalayan glacial meltwater across Bhutan, Nepal, and India to highlight the urgent realities of climate change. A distinguished panel featuring Professor Fiona Stanley AC, Richard McKenzie Head of WA Treasury Corporation, Bill Scanlan of EY Perth, and Dr Deki Choden of Curtin University, discussed themes of Indigenous knowledge, ESG in finance, values-driven leadership, and embedding sustainability into economic frameworks. Guests had an enjoyable time participating at an interactive quiz and were moved by a heartfelt letter from a 12-year-old Bhutanese student calling for climate action.







SDG Forum 4: Stronger Together: Connecting & Belonging through Sports

On 20 August 2025, in partnership with the West Coast Eagles, UNAAWA hosted its annual SDG Forum at Mineral Resources Park. The forum explored the importance intergenerational support and how it can reduce loneliness, foster inclusion, and advance the UN Sustainable Development Goals. Describing loneliness as a "quiet crisis", the forum highlighted sport's role in transforming isolation into connection. The panel session featured Mel Toia of West Coast Eagles, Hayden Marchetto of WA All Abilities Foundation, Elsie Blay of Ruah Community Services, and Chris Twomey of WA Council of Social Services (WACOSS), who shared perspectives on building a community through sport, dignity, and inclusion. The evening also showcased the West Coast Eagles' Connecting Generations Program, an interactive SDG quiz, and networking to inspire cross-sector collaboration. Now in its 5th year, the partnership demonstrates how sport can unite communities and drive local action on global goals.







## 13th United Nations Business and Human Rights Forum

In late November 2024, I had the honour of attending the 13th United Nations Business & Human Rights Forum at UNHQ in Geneva. It is the world's largest annual gathering on business and human rights. With nearly double the participants from 2023, 4000 attendees of the government, private sector, civil society, international organisations, trade unions, academia and media gathered at the two-day forum sharing key learnings from business practices and multistakeholder initiatives amidst major disruptions in technology and demands for compliance and global governance. Key discussions centred on corporate responsibility in conflict zones, protecting Indigenous rights during the global energy transition, and advancing the UN Guiding Principles on Business and Human Rights (UNGPs) in the face of growing global inequalities. An urgent and cross-cutting theme was the disruptive potential of artificial intelligence (AI)—its capacity to empower communities or entrench exclusion.

I contributed to two working group sessions on AI governance, trade, and ethical inclusion. It was highlighted at the sessions, the importance of embedding cross-cultural perspectives, particularly from Asia, into global frameworks to ensure that AI-driven solutions remain equitable, inclusive, and responsive to diverse contexts. I also participated in the progress of educational curriculum on human rights for the business sector – an initiative formed in 2022 between the International Labour Organisation (ILO), Geneva School of Economics and Management - UNIGE, and the Global Business School Network (GBSN).

The Forum also underscored the need for principled global leadership at a time of geopolitical volatility. Speakers emphasised that companies and investors hold pivotal responsibility in aligning corporate ambition with human dignity. Sustainable investment and responsible business practices were framed not only as ethical imperatives but as strategic necessities that underpin long-term competitiveness, innovation, and resilience. Beyond the plenary and working groups, the Forum highlighted opportunities to engage with practitioners whose tireless efforts are shaping meaningful change worldwide. These exchanges reinforced the value of collective action and the profound difference it can make when driven by shared purpose and global solidarity. While the challenges ahead are immense, the Forum reaffirmed the urgency of sincere collaboration across governments, business, and communities.







#### Al for Good Global Summit at the United Nations

I had the privilege to participate as a delegate at the AI for Good Global Summit in Geneva, hosted by the International Telecommunication Union (ITU), where global leaders, innovators, and policymakers came together to explore how artificial intelligence can shape our collective future and accelerate progress towards the UN SDGs. This year's discussions moved beyond governance and philosophy to pressing questions of authenticity, inclusion, and responsibility. A major focus was the emergence of agentic AI—systems capable of acting without human oversight—and the urgent need for guardrails to prevent misuse in disinformation, media, and warfare. Nobel laureate Geoffrey Hinton, known as the "Godfather of AI," cautioned that advanced AI could soon outpace human control, stressing the importance of global safety standards and cooperation.

Amid these sobering warnings, the Summit celebrated innovation from across the globe. The Al Innovators of the Year from Africa, Nepal, Mongolia, and South Korea highlighted how impactful solutions are being developed far beyond Silicon Valley. Encounters with young leaders—including the youngest TEDx speaker—were a reminder that the next generation is already shaping this dialogue. It was inspiring to connect with women leaders and changemakers in Al, building friendships that will extend beyond the summit. I am grateful to the ITU team and its leadership for convening such a meaningful platform, and I look forward to contributing to ongoing dialogue on building an ethical, inclusive, and globally relevant Al future.



# TREASURER'S REPORT

YEAR ENDED 30 JUNE 2025

On behalf of the Board, I am pleased to present the Treasurer's Report for the year ended 30 June 2025.

#### **Financial Performance**

The organisation recorded a modest net deficit of \$656 for the year, compared with a surplus of \$7,372 in 2024. The Women's Grant for a Stronger Future income was received in 2024 and, under accounting standard AASB 1058 (Income of Not-for-Profit Entities), the income had to be recognised straight away, even though the related expenses incurred in 2025.

#### **Financial Position**

As of 30 June 2025, the organisation held total assets of \$91,923 (2024: \$88,430).

- Cash remains strong at \$85,544, boosted by two new term deposits worth \$50,000, giving the organisation a solid financial base for the future.
- mainly due to invoices received at the end of the financial year and income received in advance.

Although we recorded a small deficit this year, our reserves remain stable, and the organisation is in a good position to meet its ongoing commitments.

#### **Looking Ahead**

The coming year will focus on:

- Rebuilding income streams, particularly through events, sponsorship, and potential grants.
- Maintaining tight control over expenditure.
- Leveraging term deposits to strengthen financial sustainability.

The Board remains committed to ensuring that funds are managed prudently and that resources are directed towards achieving the organisation's mission.
