PRESIDENT'S REPORT

Dear UNAAWA members, friends and family,

Serving with this organisation gives me much pride and satisfaction. This is the reason I volunteered when I started, and is much more so presently. The standout feature that distinguishes the UNAAWA is the spirit of goodwill and common purpose, which I see clearly in our volunteers who make up our organisation, who serve selflessly, sacrificing much time elsewhere to advance our mission. I give heartfelt thanks to each and every one of you for all the time and effort you have given and continue to give to the UNAAWA. Our organisation depends on your hard work, and that is what drives us and has made us successful, and without your support or that of our many sponsors and members, none of what we have done would have occurred. The UNAAWA exists because of the volunteers, and I am always grateful to work with you and learn from you.

To our executive team, it is and remains a privilege to serve alongside with you, to have your support and I will always continue to support each of you in any way I can.

Over this past year we have continued to grow, and our organisation is stronger today, with strong financial reserve and an executive team committed to delivering for our members.

In our efforts to increase engagement with local government authorities, we have met with the representatives from the City of Cockburn and City of Melville, with the aim of increasing partnership to raise awareness amongst the residents of those councils of the UN mission, to promote our events and encourage attendance, and in return to promote their events amongst our members. Additionally, with far greater potential impact, our organisation is presently working hard to reach similar arrangements with the WA Local Government Association (WALGA), which aims to ensure a much broader consistency of the partnership arrangements, for the benefit of all the council's residents and the communities in Western Australia.

The UNAAWA's advocacy work on Human Rights, the Environment, Gender Equality, the Sustainable Development Goals (SDGs) and Young Professionals continue to make an impact and increase our engagement with the community. These events have not only brought us together but also inspire others, encourages and increases partnerships, as well as serve as models to follow to raise awareness of the UN goals to make our world a better place. With the aim of spreading of and raising awareness of the UN goals, the UNAAWA has expanded over the past year in its scope and activities and has continued in its mission.

Our biggest event of the year is ahead, namely our UN Day Gala, where we will celebrate the 79th Anniversary of the United Nations on 18 October 2024 at the Duxton Hotel. At the UN Day Gala, we will welcome state leaders, consuls, industry figures, community champions and committed individuals. Furthermore, this event is important to our organisation's fund-raising, in order to enable us to continue to work to promoting our mission. We can look forward to come together on that day to celebrate the values of global solidarity with a sense of hope, upon which the UNAAWA was founded, and to remind ourselves we are united by more than what divides us.





Always, I am reminded that ultimately, it is in one another that we can find the best in our shared humanity.

FINANCIAL OUTLOOK

BALANCE SHEET, TOTAL EQUITY

On the financial front, I am pleased to announce that the UNAAWA has continued to manage our financial resources with diligence. UNAAWA has continued to stay financially solvent, and that we have managed to grow our fundraising through efforts by committee convenors and members. I wish to commend the professionalism of our Treasurer and all those who contributed for ensuring the long-term sustained financial health of our organisation.

As of the 30 June 2024, the organisation's total net assets stand at \$84,838.74 which is a 9.52% increase over the previous financial year. The Treasurer is currently exploring opportunities to invest our reserves strategically, including in term deposits, to further strengthen our financial sustainability and support our ongoing initiatives.

The most important source of income for 2024 remains the Association's fundraising events, including but not limited to the UN Day Gala, the SDG Business Forums, the Members networking events, including all activities organised by the Young Professionals, Environment, Gender Equality and Human Rights committees. I take this opportunity to commend our Convenors for Young Professionals and Gender Equality for bringing in a sponsorship of \$10,444.55 and a grant of \$8558.00. While we have had a reduction in membership income over the past financial year, we are pleased to report an operating surplus of \$7371.71, which enhances our financial position and enables us to reinvest in our programs and mission. We recognise the hard work of our dedicated volunteers, members and convenors who have collectively enabled the UNAAWA to obtain sponsorships and other sources.

MEMBERSHIP

The distribution of memberships remains consistent with the previous financial year, with the most popular membership category remaining the 1-year Ordinary type (61), followed by the 1-year Concession type (21). The membership as of 30 June 2024 numbers 145 compared to 154 in 2022, but Organisational 1-year membership (includes corporates, governments, and universities) has doubled this past year, with Member's Ordinary 3-year memberships has also increased, with Young Professionals membership numbers increasing from 3 to 22.

VICE PRESIDENT'S REPORT - Strategy & Partnership

It has been a rewarding experience serving in the capacity as Vice President for Strategy and Partnership during the 2023-2024 Financial Year.

Guided by a compass of unwavering commitment, I led and contributed to **four key activities** that promoted the work of the UNAAWA, strengthened partnerships and recognised the significant contribution and transformative minds of our volunteers. I did these activities as seeds of change and purposeful strategies that informed, inspired and engaged the WA communities in the vision and work of the United Nations to build a more sustainable world.

1. OMI Multicultural Awards 2024: I prepared the award nomination on the inspiring work of UNAAWA's committees. We were selected as a finalist in the Community Service and Support Award-General Community Service Organisation category at the Western Australian Multicultural Awards 2024 Ceremony, hosted by the Office of Multicultural Interests (OMI). The event took place on 14 March 2024, at the Ritz Carlton Hotel. Congratulations to the category winner, Mission Australia, for their outstanding work in providing safe social housing for vulnerable people and families. Representing UNAAWA at this award ceremony was a privilege, allowing me to learn about the exceptional efforts of other finalists and winners and identify prospective partners.



- 2. Rewiring Australia's Public Forum: On 20 March 2024, at the WA Museum Boola Bardip in Perth, Saul Griffith, co-founder of Rewiring Australia and an author, delivered an inspiring presentation. His vision centred around Western Australia (WA) leading the world in the transition to safe renewable energy. During the panel discussion, I emphasised the importance of engaging all community members to ensure no one is left behind in this transition. Additionally, I informed the audience about Australia's progress on key Sustainable Development Goals (SDGs) related to renewable energy:
 - SDG 7 Affordable and clean energy;
 - 2. **SDG 9** Industry, innovation, and infrastructure;
 - 3. SDG 10 Reduced inequalities;
 - 4. **SDG 11** Sustainable cities and communities; and
 - 5. **SDG 17** Partnerships for the goals.





The other panellists included Katherine McConnell (CEO and founder of Brighte), Kylie Turner (Climateworks Centre), and the chair, Meri Fatin (WA Climate Leaders Inc and Supercharge WA). The event was a resounding success, with 325 people attending in person and 60 online. Kudos to Lily Jovic, the event coordinator, for her outstanding work. My networking efforts also paid off, as I connected with several prospective partners during the event.



3. Re-establish partnership with WALGA: During April and May 2024, I initiated and reestablished partnership between UNAAWA and the Western Australia Local Government Association (WALGA). On 16 May 2024 we had a partnership meeting at WALGA, attended by Rebecca Brown (Manager, Waste and Environment) Keith Walsh (Policy Officer Environment) and Mackenzie Young (Waste Management Support Officer), Dr Sandy Chong (Immediate Past President & Chair of SDG Forum) and me. The partnership proposal included: co-hosting a SDG Forum in partnership with UNAAWA's existing partners, sponsors and stakeholders with a specialised focus on Local Governments (LG) advancement and impact on SDGs; and co-design, socialise and promote for a LG awards category at the UN Day Event, held annually in October. Additionally, I prepared and delivered a presentation that informed and inspired 47 registered local government representatives about the UN SDGs and Local Government in WA at the WALGA Webinar on 17 July 2024.



For 2024, the Human Rights Committee has been very focused on activities in line with the United Nations Sustainable Development Goals (UN SDG) 10 (Reducing Inequalities) and 16 (Peace, Justice and Strong Institutions). We have delivered these goals through panel discussions and attending forums, allowing for an opportunity to engage with influential people in Western Australia. The events we have been involved with and hosted included:

- Business & Human Rights: In partnership with SDG Forum Committee
 - "Beyond Extraction: Leading Governance & Human Rights for SDGs" which highlighted the pivotal role of leadership, transparency, and ethical practices to achieve good governance in the global supply chain.
- Digital Rights as Human Rights Human Rights Committee
 - In an era where technology permeates every aspect of our lives, understanding the intricacies and societal implications is paramount. The event explored fundamental human rights in a rapidly evolving digital landscape, impacting our private, public, and professional spheres. Amidst this discourse, a plausible questions were asked about whether technological tools and education are equitably distributed between urban centers and rural areas; and whether we can realistically strive for equitable distribution. The feasibility and implications of achieving parity were discussed to enable access and opportunity for WA.
- Health: Access & Equity
 - This event dived into vital conversations during Mental Health Week that aim to enhance healthcare accessibility and champion equity for all, especially the vulnerable groups across Western Australia.

GENDER EQUALITY COMMITTEE



The reporting period of 2023-2024 was an exciting year for the Gender Equality Committee (GEC). This year, our efforts have been dedicated to advancing gender equality and empowering women and girls through stronger community engagement and strategic partnerships. The Gender Equality Committee (GEC) recognises the power of collaboration to advance towards Sustainable Development Goal (SDG) 5: Achieve gender equality and empower all women and girls. The following SDG 5 targets continue to drive our work:

Target 5.1 – End all forms of discrimination against all women and girls everywhere;

Target 5.2 – Eliminate all forms of violence against all women and girls in the public and private spheres, including trafficking and sexual and other types of exploitation; and

Target 5.5 – Ensure women's full and effective participation and equal opportunities for leadership at all levels of decision-making in political, economic and public life.

In the past year, the Gender Equality Committee (GEC) has continued to make significant strides at the local level, driving progress toward national and global goals for enhancing the well-being of girls and women. Our recent achievements include securing funding from the government's Stronger Women for a Stronger Future grant, hosting International Women's Day with keynote speaker Senator Fatima Payman, and founding and chairing the inaugural Thrive Gala in partnership with Zonta House to honour women survivors of domestic violence. These accomplishments highlight the relentless dedication and passion of our members and demonstrate the enduring impact of our commitment to gender equality.

SDG BUSINESS FORUM SERIES COMMITTEE





The UNAAWA organised three SDG Forums in the past 12 months. The Forums were titled "Sustaining Earth and Beyond: Space Innovation and Achieving SDGs" in partnership with the Young Professionals Committee at Pawsey Supercomputing; "Beyond Extractions – Leading Governance & Human Rights for SDGs" " in partnership with the Young Professionals Committee at KPMG; and "First Nations People and the 2030 Agenda" sponsored by BHP and hosted at the West Coast Eagles' Mineral Resource Park. An upcoming Forum will be held on 30 October this month sponsored by Murdoch University titled "Driving SDG Progress: Public Sector Innovation".

SDG Forum 1: Sustaining Earth and Beyond: Space Innovation and Achieving SDGs

An SDG Forum was held on the 5 October at Pawsey Supercomputing, opened by WA Minister for Innovation and the Digital Economy, the Hon. Stephen Dawson. He outlined the government's commitment to the UNSDG goals, the benefits and opportunities that progress in the space domain and how the state could become the southern hemisphere's global hub for space development and operations. Esteemed speakers featuring former NASA scientist, Dawn McIntosh, Dr Clancy James, a radio astronomer based at the Curtin Institute of Radio Astronomy, Michelle Keegan, Program Director AROSE and James Yuen, Director for Space Innovation, Department of JTSI. Insights shared on the panel discussion demonstrate the increased desire to make space exploration more sustainable, referring to both the execution of missions and the end of life for the technology launched into space. The event was attended by over 100 guests, UNAAWA members, students, industry and community partners.







SDG Forum 2: Beyond Extractions – Leading Governance & Human Rights for SDGs

Following up from last year's "Leadership and Governance in the Extractives" Roundtable, a pivotal Forum was convened at KPMG on 14th May 2024. The event brought together leaders from government, academia, and the private sector to address critical issues at the intersection of governance, human rights, and sustainable development within the extractive industry. Claire Murray, State Director of DFAT and WA Attorney General, the Hon. Minister John Quigley MLA, highlighted Australia's commitment to promoting responsible resource governance and advancing human rights through legislative reforms efforts. Panel speakers include: Shaeron Yapp of Rio Tinto, Amanda Murphy of BHP Billiton, Serena Grant of Minderoo's Walk Free Foundation, and Professor Anthony Langlois of Curtin University, shared insights relating to labour exploitation, indigenous engagement, and modern slavery. Strategies to overcome such challenges discussed include promoting industry-wide responsible practices, partnerships, and the need for education.



SDG Forum 3: First Nations People and the 2030 Agenda

The SDG Forum on 1 August marked the fourth anniversary of our partnership with West Coast Eagles in the promotion of the SDG goals in our community. The event spotlighted the essential contributions of Indigenous peoples towards achieving the Sustainable Development Goals (SDGs), bringing together leading experts and advocates to discuss the integration of First Nations perspectives across various sectors in science, culture, politics, education and business. Distinguished First Nations speakers include: Dr. Kate George, Andrew Beck, Professor Christopher Lawrence, Sharyn Egan, and Clinton Walker. In addition to sharing insights on resilience, culture and leadership, the panel also highlighted the importance of Indigenous knowledge education, integrating in preserving culture. supporting entrepreneurship, and promoting technological inclusion. Over 120 attendees were inspired by our First Nations peoples' dedication in protecting our land and had a great time participating at the event. We thanked Meredith Hammat MLA - Member of Mirrabooka who represented Minister Tony Buti, Geoff Baker MLA - Member of South Perth, UNAAWA members, series sponsors and our First Nations community for their amazing support in making the event a successful one.







12th United Nations Business and Human Rights Forum

In late November 2023, I had the pleasure of attending the 12th United Nations Business & Human Rights Forum at UNHQ in Geneva. It is the world's largest annual gathering on business and human rights. With nearly double the participants from 2022, 4000 attendees of the government, private sector, civil society, international organisations, trade unions, academia and media gathered at the two-day forum sharing key learnings from business practices and multistakeholder initiatives amidst major disruptions in technology and demands for compliance and global governance. Following the attendance of the Forum, I was invited to participate in the progress of educational curriculum on human rights for the business sector – an initiative formed in 2022 between the International Labour Organisation (ILO), Geneva School of Economics and Management - UNIGE, and the Global Business School Network (GBSN). I also participated at a roundtable session convened by the World Economic Forum (WEF) and the TASC Platform of the Graduate Institute of Geneva that explored global study cases that will contribute to ongoing research and concrete recommendations for a policy paper on "Trade Tools for Better Labour Outcomes".







WIN Conference at the United Nations

I was invited to deliver a keynote on "World in Transformation" at the United Nations in Geneva for the Women's International Networking (WIN) Conference. The event highlighted the transformative impact of women in leadership, emphasising unity and collaboration in a polarised world, and unlocking opportunities in times of change. Alongside esteemed panellists such as the Ambassador of Chile to the WTO Sofia Boza, and Human Rights defender Karen Tse, I shared perspectives on the role of female leaders in driving sustainability, international trade, and global innovation. In particular, how women in Asia-Pacific are contributing to environmental stewardship, economic resilience, and digital inclusion. The energy, passion, and collective wisdom shared by attendees and speakers alike were truly remarkable which is a testament to the allyship of female leaders and male champions worldwide.



Al for Good Global Summit at the United Nations

Al for Good Global Summit, hosted by the International Telecommunication Union (ITU) – the UN agency for digital technology, was held in late May. The Summit brought together thousands of participants from all sectors around the world to discuss the development about Artificial Intelligence (AI) and how it can be an accelerator to achieving the UN SDG Goals. I was invited to share insights on a panel alongside academics, activists, practitioners and policy makers. We delved into the vital distinction between digital and AI inclusion, the need to adopt a nuance approach to ensure representation, and the challenge for us to consider how AI can embody the best of humanity. Highlights of the event include meeting the Secretary-General of ITU, Doreen Bogdan-Martin, and attending sessions with Director-Generals of various UN agencies from the World Intellectual Property Organization (WIPO), International Labour Organisation (ILO), to the Food and Agriculture Organisation (FAO), Microsoft, as well as the International Monetary Fund (IMF). It was asserted that AI could be a game-changer for the SDGs and global coordination is needed to build safe and inclusive AI that is accessible to everyone.

I had the privilege of attending the International Labour Conference (ILC) in Geneva where the Global Coalition for Social Justice was launched at the United Nations. This initiative transcends policy-making—it touches the heart of livelihood and dignity. Director-General of the International Labour Organization (ILO), Gilbert F. Houngbo, shared a compelling vision for the coalition, focusing on sustainable development and the need for a global movement that brings tangible improvements to people's lives. It's not just about securing jobs; it's about ensuring that work provides fulfillment and meaning. Dr. Tedros Adhanom Ghebreyesus, Director-General of the World Health Organization (WHO) also highlighted the critical connection between health and social justice at the launch and emphasised how wellbeing is essential to building resilient communities.

With rapid changes in energy and digital technologies, it's estimated that up to 50% of jobs could be significantly impacted. This underscores the urgency for corporations and governments to guide people through these transitions. Inspired by the coalition's vision and the collective commitment, I aim to continue in expanding our advocacy of the SDGs for a more just and equitable world.

YOUNG PROFESSIONALS COMMITTEE

The reporting period of 2023-2024 was a year for strategy and building capacity.

Since the Committee's founding in the 2022-2023 year, our efforts have been dedicated to advancing leadership skills of young professionals by identifying skills needed to empower more SDG progress by young professionals in their everyday roles, and research into connecting academics with not-for-profit causes. These actions align with the following SDG targets:

- Target 17.7 Encourage and promote effective public, public-private and civil society partnerships, building on the experience and resourcing strategies of partnerships;

UN Day 2023 - 78TH Anniversary of the founding of the united nations, Duxton Hotel

On **20th October 2023**, the UNAAWA celebrated the 78th anniversary of the founding of the United Nations at **The Duxton Hotel**. Sustainability was the key UN theme for 2023. Chaired by Zaina Debouch, the event was attended by over 120 guests including the members UNAAWA, dignitaries from the DFAT, Vietnam, Malaysia, Thailand, Japan, China, the US, Greece and Brazil, representatives of federal and state ministries, members of the WA Indigenous Tourism Council (WAITOC), members of the Rotary Club of Perth, Presidents of community associations, and our sponsors from both public and private sectors. Opening remarks were made by the President of UNAAWA, Randhir Amoganthan on sustainability.



TREASURER'S REPORT

For the Year Ended 30 June 2024

For the first year of my term as Treasurer of the United Nations Association of Australia WA Division, I am pleased to present the financial report for the financial year ending 30 June 2024 which has been prepared in accordance with the requirements of the Australian Charities and Not-for-profits Commission (ACNC). I want to express my gratitude to the previous Treasurer, Manisha, for her dedicated service and help with the handover and to the Assistant Treasurer, Yuko Roos, for her ongoing support. Their contributions have been invaluable in guiding us to this point.

The organisation achieved positive financial results, with a total revenue of \$47k for 2024, an increase of \$10k from the previous financial year FY23. To ensure clarity and accuracy in our reporting, we have adjusted the financial performance and position figures for FY23. The movement in revenue can be attributed to several key factors including, sponsorship of \$9k* received by the Young Professional Subcommittee, Women's Grant for a Stronger Future: \$8k* received by the Gender Equity Subcommittee, decrease in Membership of \$3k, and decrease in Events income of \$4k. *Note: Sponsorship and grant income is recognised in the financial year it is received in accordance with accounting standards. However, expenditures related to these funds may occur in future financial periods.

The operating expenses for the financial year 2024 were \$13k, an increase on the previous year due to payments to the United Nations Association of Australia National Division and fees for professional advice. Despite these higher costs, we are pleased to report a surplus of \$7k, which enhances our financial position. As of 30 June 2024, the organisation's total net assets are \$84k, an increase of 9.52% over the previous year. We are also exploring opportunities to invest our cash reserves strategically to strengthen our financial sustainability further and support our ongoing initiatives.

In conclusion, The United Nations Association of Australia WA Division is in a strong financial position, with a surplus that reflects our commitment to prudent financial management and long-term financial health of the organisation. I, Amanda Cumberbatch being the Treasurer of United Nations Association of Australia WA Division, certify that the Statements attached to this annual report give a true and fair view of the financial position and performance of the United Nations Association of Australia WA Division Incorporated during and at the end of the financial year ending on 30 June 2023.
