#### PRESIDENT'S REPORT

Dear UNAAWA Members, Friends and Family,

This is my first President's report of my three-year mandate. It is certainly an honour and a privilege to lead this organisation, especially working with all the amazing volunteers that make up our organisation. I thank each and every one of you for all the time and effort which you have poured into the UNAAWA. Your hard work is what has made us successful, and without your support or that of our many sponsors and members, none of the amazing initiatives which you'll read about in these pages would have been possible. The UNAAWA exists thanks to you, and it has been one of the highlights of my career in volunteerism to work with you and learn from you.

Over this past year we have continued to grow, and our organisation is stronger today, with better financial reserve and an executive team committed to delivering for our members. This year alone, our total equity has increased by a further 6.26 percent, and our membership remains stable, and we are more diverse than ever.

The UNAAWA's advocacy work on Human Rights, the Environment, Gender Equality, the Sustainable Development Goals (SDGs) and Young Professionals, has brought us together and places the UNAAWA firmly on the map in Western Australia.

These great achievements are not only inspiring but also serve as models to follow but demonstrates the very real impact the UNAAWA can have in changing and improving the lives of those in our communities to play a role in making our world a better place.

It is often said that once you become aware of the issue at hand, half the battle is already won. These partnerships create many new opportunities for awareness and advocacy, and enables us to expand our mission and impact on humanitarian causes and raising awareness of these issues within society in Western Australia. With the aim of spreading of and raising awareness of the UN goals, the UNAAWA has expanded over the past year in its scope and activities.

In 2023, the UNAAWA has begun to work more closely with UN Youth, with the aim to deliver WACE-endorsed programs to schools and students in Western Australia. An MOU is presently under consideration to set out the groundwork for this cooperation, with the aim of working together to spread awareness of the UN activities and goals.

Once again, to all our committees and convenors, thank you for your hard work and dedication. All the events and initiatives we have undertaken have been possible because of your commitment to the goals and values of the UNAAWA. To our executive team, it has been a privilege to serve alongside with you and to have your support. I am sure that our best work is still to come, and I will always continue to support each of you.

But of course, our biggest event of the year is still ahead of us. So please, if you have not already booked your tickets for October's UN Day Gala, which will celebrate the 78<sup>th</sup> Anniversary of the United Nations on 20 October 2023 at the Duxton Hotel.





At the Gala, you will not only meet local champions and state leaders, consuls general, industry figures and many more passionate individuals at the event but will also help us to raise funds for work in promoting peace and multilateralism. I have every confidence that this year's Gala will once again be a resounding success and I look forward to seeing all of you there.

Whatever changes and turbulence may occur, we can look forward to overcoming these, and come together to celebrate the values of global solidarity which we all yearn for; a sense of hope which the UNAAWA was founded to support and help grow, and remind ourselves that we are united by more than what divides us, and that in one another, we can find the best in our shared humanity.

#### **FINANCIAL OUTLOOK**

On the financial front, I am pleased to announce that the UNAAWA has continued to manage our financial resources with diligence. UNAAWA has continued to stay financially solvent, and that we have managed to grow our fundraising efforts through the careful stewardship of our volunteers. The work has been challenging, but I wish to commend the professionalism of our Treasurer and all those who contributed for ensuring the financial health of our organisation.

The composition of income received has changed considerably from FY2022. Income for the past 12 months has dropped from \$70,719.05 to \$35,187.12. Over the years the UNAAWA had received a grant from Lotterywest but since FY2022, due to changes in the Lotterywest grant criteria, the access to funding is no longer available. However, it is extremely pleasing to recognise that through the hard work of our dedicated volunteers and members, collectively UNAAWA was able to obtain sponsorships and other sources. The most important source of income for 2023 remains the Association's fundraising events, including but not limited to the UN Day Gala, the SDG Business Forums, the Members networking events, including all activities organised by the Young Professionals, Environment, Gender Equality and Human Rights committees. The Other Income category proportion nearly doubled between FY2022 to FY2023 mainly due to increase in sale of promotional items.

The UNAAWA continues to have an annual operating surplus, and annual Member's Funds continue to grow between FY2022 to FY2023.

#### **Balance Sheet & Total Equity**

The Total Equity (Assets less Liabilities) continue to grow year on year, with a 6.26% increase from \$77,925.97 in FY2022 to \$82,806.56 in FY2023. This increase was partly attributable to the Association's relentless members engagement programs, as well as cost containment measures implemented in the previous financial year. We expect that the effects of these measures will continue to have beneficial effects for the UNAAWA.


Despite the current challenges, our Association has continued to deliver successful events and create a positive impact on the communities. The funds raised over the last 12 months allow us to pursue our advocacy work and promote the importance of Human Rights, Environment, Gender Equality, and the Sustainable Development Goals.





#### Membership

The distribution of memberships remains consistent with the previous financial year, with the most popular membership category remaining the 1-year Ordinary type (52%), followed by the 1-year Concession type (21%). The membership as of 30 June numbers 154 compared to 171 in 2022, but Organisational 1-year membership (includes corporates, governments, and universities) has doubled this past year, with Member's Ordinary 3-year memberships more than doubled.

#### VICE PRESIDENT'S REPORT - STRATEGY

It has been a rewarding experience serving in the capacity as Vice President for Strategy and Partnership. My strategic goals for the Financial Year 2022-2023 were to:

- 1. Take a coordinated approach to long-term sponsorships;
- 2. Enhance synergy among volunteers and committees; and
- 3. Increase the profile and appreciation of the volunteers and their work.

In pursuing Goal one - I supported the Environment Committee in developing a sponsorship proposal that was submitted to a partner. #### **Events Report:**

#### Collaboration for Climate | Sustainable Development Goal 13: Climate Action

On March 1, 2023, the UNAAWA and Curtin University Faculty of Business and Law co-hosted the Collaboration for Climate event. It united government, industry, academia, and community representatives to discuss climate change strategies. Notable moments included a Welcome to Country, talks by UNAAWA's President Randhir Amoganathan Hon. Reece Whitby MLA, Minister for Environment and Climate Action, and a call to action from Curtin student Harry Bidewell. Session chaired by Dr Sandy Chong, experts on a panel examined collaboration challenges, successful examples, and practical individual steps for climate action. Supported by Carbon Neutral, the event concluded with over 140 participants inspired to foster cross-sector cooperation.



#### **UN SDG School Artwork Competition**

The UN SDG School Artwork Competition actively engaged Year 5 students at St Joseph's Catholic Primary School Pinjarra in understanding and contributing to the UN SDGs. The competition aimed to expand students' global awareness and inspire their actions towards the SDGs. UNAAWA provided online resources aligned with the UN SDGs to facilitate teachers in this educational journey. An important facet of this facilitation involved encouraging students to creatively express their thoughts, ideas, and values associated with the SDGs through artwork. These artistic pieces are used to create unique UNAAWA merchandise items to sell publicly to fundraise for the UNAAWA and promote the SDGs.







#### World Oceans Day | Sustainable Development Goal 14: Life Below Water

The Environment Committee marked World Oceans Day on June 13, 2023, at the Old Courthouse in Fremantle. This event created a casual yet professional platform, focused on fostering positive future-oriented discussions about ocean conservation in alignment with the UN Ocean Decade. The gathering explored personal interpretations of the UN Ocean Decade's significance and actionable steps for everyday individuals to contribute to ocean conservation in Western Australia and beyond. Distinguished speakers included Prof. Jennifer Verduin, Pro Vice Chancellor, College of Environmental and Life Sciences and Senior Lecturer in Oceanography at Murdoch University; Dr. Luke Twomey, CEO of the Western Australian Marine Science Institution; and Dr. Bec Wellard, Program Manager for Ocean Conservation at the Minderoo Foundation. The event aimed to inspire and guide those interested in ocean conservation, providing insights into the next steps for individuals seeking to enter the field.

# HUMAN RIGHTS COMMITTEE



As our community began the slow road to recovery from the COVID-19 pandemic, the past year has been a challenging but equally transformative for our committee. As we look back on the year we had and what we have been able to achieve as a committee, we are reminded and grateful for the role each of the Human Rights Committee members and volunteers have played to making our community a more just and equitable one.

This year we were committed to bring our community together and closer to the mission of the United Nations (UN). Our aim was to advance UN's agenda through systemic advocacy and community engagement initiatives that foster dialogue and active participation on local, regional, and international issues that are central to Universal Declaration of Human Rights and all its instruments.

#### **Systemic Advocacy work**

#### **Submission to the Commonwealth Inquiry on Poverty**

The Committee was dedicated to further the United Nations mission through systemic advocacy of the principles of the Universal Declaration of Human Rights and its instruments. As such, in January 2023, the UNAAWA Human Rights Committee made a submission to the Senate Community Affairs References Committee's **Inquiry into the Extent and Nature of Poverty in Australia**. The United Nations Universal Declaration of Human Rights sets out a standard that outlines basic equality and rights to ensure people's basic needs are met. Everyone has inherent entitlement to live with dignity and the opportunity to participate in society to their fullest capability. Poverty endangers these fundamental rights. The submission looked at the impacts





of poverty on race; gender and; children. It highlighted communities that experience racism, racial discrimination and poverty at a higher rate due to social exclusion and minimised economic opportunity. The submission made a number of recommendations to address and reduce poverty. These included:

- Implementation of the UN Guiding Principles on Extreme Poverty and Human Rights to recognise the inequalities associated with the cause and impact of poverty.
- Implementation of the *Uluru Statement from the Heart* for strong self-determination and better economic, educational and health outcomes for Indigenous communities around Australia.
- Strengthening federal human rights and anti-discrimination legislations for stronger protections focused on equality of outcomes for vulnerable communities.

#### **Submission to the Australian Human Rights Commission**



The Human Rights Committee responded to calls for submission by the Australian Human Rights Commission on reforms to Australia's youth justice and child wellbeing systems. The UN has done extensive work to guide states in establishing systems that support children and young people engaged with justice system. The submission highlighted the importance of centring children's rights at the heart of youth justice reform to ensure a humane and effective treatment of young people when engaged with the criminal justice system. The United Nations Universal Declaration of Human Rights and the Convention on the Rights of the Child (CRC) provide basic guide to the inherent entitlements children and young people to live with dignity and have


the opportunity to participate in society to their fullest capability.

The submission called for Australia's youth justice reform to ensure specific adherence to the international treaties it is a party to and rules that govern basic principles on youth detention practices. It called for considerations to be given to the Beijing Rules, the Riyadh Guidelines and the UN Rules for the Protection of Children Deprived of Their Liberty. It is important that youth detention practices are shaped to promote youth-centred and rights-based practices that aid the development and rehabilitation of children and young people.

#### **Events and Community Engagement work**

**UN International Day for Elimination of Racial Discrimination** 





The Human Rights Committee joined the United Nations on the March 21, 2023, to commemorate the Sharpeville Massacre, peaceful protestors who were massacred by Apartheid police in South Africa while demonstrating their resistance to racist laws and discriminatory systems. Supported by the executives and members of all committees at the UNAAWA, a video campaign was released to reaffirm our commitment for a world free from discrimination and prejudice. The aim of the video was to stand in solidarity with people who fight racism and encourage our community to take every opportunity to listen, learn and stand against racism and racial discrimination.

#### **National Reconciliation Week**

The Human Rights Committee had the privilege of supporting this year's Reconciliation WA's NRW Virtual Breakfast. Reconciliation Week was held between 27 May to 3 June every year and provides an opportunity for all Australians to reflect on our responsibility to bridge the gap between Aboriginal and Torres Strait Islander communities and non-Indigenous Australians. This year's theme is 'Be a Voice for Generations' which encourages all of us to be a voice of reconciliation in meaningful ways every day. The Committee had the opportunity to hear from many Aboriginal leaders and allies in our community about what the journey to reconciliation has entailed throughout our



shared history and the road ahead for a fully healed and reconciled Australia. Our Committee also took part in Reconciliation WA's Uluru Youth Yarns which was held on Saturday 27 at The Constitutional Centre of WA. Samuel Pilot-Kickett delivered an energetic and educational Welcome to Country which set the tone for a youthful dialogue about the Uluru Statement from the Heart and The Voice to Parliament.







The highlight of the event was hearing from young leaders Sophie Coffin, a Nyangumarta Yindjibarndi woman and Tyson McEwan, a Ngarluma Bardi man who were very generous in sharing their knowledge and experiences.

The event provided a special opportunity for community members and particularly young leaders to connect and have honest conversations about The Statement and The Voice.

#### **UN Refugee Day 2023**




In celebrating Refugee Week this year, the Committee organised a Refugee Week event in partnership with Refugee Council of Australia and the Equal Opportunity Commission. The event hosted Assadullah Khurrami, a former refugee from Afghanistan, who delivered a touching and inspiring keynote followed by a Q and A with UNAAWA and the community. Assadulah generously shared his inspiring journey as a former asylum seeker who overcame incredible challenges and built a new life here in Perth, Western Australia.

The event was a great opportunity to celebrate the resilience and courage of refugees and former refugees like Assadulah, and to learn more about the challenges they face when finding freedom.





#### **NAIDOC WEEK 2023**



The Human Rights Committee had the opportunity to take part in a Yarning session with the Uluru Dialogue. It was a unique opportunity to hear from Co-Chairs Pat Dodson AO, Professor Megan Davis facilitated by Lucy Davis and paid tribute to the Elders who played a significant role in the lives of the presenters. The session also provided an overview of the regional dialogues that led to the largest consensus of Australian First Nations on the invitation for substantive recognition, the Uluru Statement from the Heart. The Statement is an invitation that asks Australians walk together with First Nations in building a better future, one that establishes a First Nations Voice to Parliament Makaratha Commission to lead national truth-telling and treaty making.

#### **UN International Nelson Mandela Day 2023**



The Human Rights Committee organised its first international event on Mandela Day in-person and livestreamed to audience from WA and Southern African countries. In partnership with Curtin University and Nelson Mandela University, the Committee hosted Professor Bheki Mngomezulu from Nelson Mandela University to celebrate UN Mandela Day. Prof. Mngomezulu delivered an insightful keynote on self-determination of Indigenous Peoples, the legacy of





colonisation and impact of racial discrimination, while Uncle Nick Abraham delivered a powerful Welcome to Country connecting us to ourselves and reminding us of the journey ahead to achieving First Nations' self-determination in Australia. Ambassador Justin Mohamed, Australia's inaugural First Nations Peoples' Ambassador also shared words on the importance of championing the rights of Indigenous peoples.

An expert panel including Wungening CEO Daniel Morrison, racial justice and human rights advocate Maria Osman and Centre for Human Right's Dr Yirga Woldeyes explored the Australian context of self-determination the importance of the year ahead as Australia prepares for a referendum to recognise Australia's First Nations in its Constitution.

#### **UN Day 2022**

#### **International Women's Day 2023**

International Women's Day (IWD) is the Gender Equality Committee's main event of the year. This year, the committee hosted their biggest event yet, with over 120 guests attending an International Women's Day breakfast held at Central Park Towers in the CBD.

The event was opened with keynotes from the Hon. Stephen Dawson, Minister for Innovation and the Digital Economy, and the UNAAWA Immediate Past President, Dr Sandy Chong. A panel of inspiring speakers gathered to discuss the theme of "DigitALL: Innovation and Technology for Gender Equality". The panel included respected Arrente woman, business owner and Aboriginal employment specialist Christine Ross, esteemed scientist Dr Kate Brooks, innovation specialist, Cettina Raccuia of RAC and technology academic Dr Andrzej Gwizdalski of the University of Western Australia.

Discussion included perspectives on Aboriginal and gendered inclusion in generating new technological solutions, highlighting a need for diverse voices to be consulted at every step in uplifting digital integration in work and society. The event concluded with Convenor Francesca Stewart calling on industry to take up the heavy lifting in upskilling women to take part in digital change.







#### 2022-2023 Young Women's Leadership Program

The flagship program of the GEC is the Young Women's Leadership Development Program (YWLDP) which has been expanded this reporting period to include a regional offering.

A Young Indigenous Women's Leadership Program was held in Albany on 18-20 November 2022 in partnership with the Great Southern Aboriginal Corporation and sponsored by the Hilton Garden Inn hotel. The GEC members travelled down to Albany to deliver the program over a weekend, which included workshops and presentations on the UN, the SDGs, leadership, women's lives and gender equality issues, community advocacy, and career management.

Since the successful delivery of this regional/Indigenous specialised program, the GEC has been in discussions to create a similar offering for Ishar Multicultural Women's Centre, tailored to a new culturally diverse audience.

This successful program is entering its fourth cohort and will be held at Curtin University on 14<sup>th</sup> and 15<sup>th</sup> October. Further specialised cohorts for indigenous and multicultural audiences are planned to take place by the end of the year.





#### **Upcoming Events**

#### 16 Days of Activism - Thrive Gala

16 Days of Activism is an annual international campaign that calls for the elimination of violence against women and girls. The GEC has developed an exciting opportunity to deliver a Thrive Gala, the first of its kind, with partner the Zonta Club of Perth. The gala will be an evening of refreshments, light entertainment and inspiring speeches, uplifting the stories of women survivors who have gone on to thrive after adverse circumstances. Sponsorships are currently being sought to support the operational costs of the event with ticket sales revenue to go towards supporting the Cultural Connections Initiative, supporting Aboriginal women through Zonta House. The venue has been kindly sponsored by Reconciliation WA, to whom we are extremely grateful.

#### Reflecting & Looking Ahead: 2023-2024

The main aim for this year's GEC strategy was to increase our reach to marginalised areas of the community and to enhance our advocacy of intersectionality. This has been achieved through strengthening partnerships and seeking opportunities to deliver service to indigenous and multicultural groups. We have also ensured diversity in our events, with broad representation of panel speakers and participants. Finally, we have enhanced the diversity of our own committee, drawing in engaged volunteers representing many intersections and demonstrating that UNAA WA GEC is a safe and inclusive committee in which to participate.

In acknowledging that we have made tremendous progress towards the strategic aims set out for 2023, we begin to think about our aims for 2024 and beyond. Our strategic theme will be defined in November with the input of our committee and will seek to reflect the needs of the community and be driven by the aims of the UN and SDG 5.

Some of our areas of focus will likely include:

- Seeking funding partners to enhance the reach of YWLP both metro and regional
- Event partnerships with UNAA WA committees
- Relationship building with government stakeholders

We look forward to another enriching and exciting year ahead, in which we continue to advance towards a gender equal future in Western Australia.

#### SDG BUSINESS FORUM SERIES COMMITTEE





The UNAAWA organised one conference, three SDG Forums and one industry roundtable in the past 12 months. The Forums were titled "Sustainable Financing: Roadmap to Achieving Decarbonisation & SDGs" at KPMG; "Future Leaders Development: Sports for Children & Achieving SDGs" sponsored by BHP and hosted at the West Coast Eagles' Mineral Resource Park; and one to be jointly organised with the UNAAWA Young Professionals at the Pawsey Computing Centre on 5 October titled "Sustaining Earth and Beyond: Space Innovation and Achieving SDGs".

#### SDG Forum 1: Sustainable Financing: Roadmap to Achieving Decarbonisation & SDGs

End of last year, the SDG Forum was held on the 8 November at KPMG with the theme of addressing the current trends of sustainable financing, the challenges and opportunities of decarbonization for Western Australia. As the Founding Chair of the Forum series, myself and the Chairman of KPMG Perth, Trevor Hart, delivered the welcoming speech for the evening. Esteemed speakers for the panel session featured Richard McKenzie of the WA Treasury, Jennifer Kirk of Department of Jobs, Tourism, Science & Innovation (JTSI), Tanya Kerkvliet of KPMG, and Caroline Chan of Stanmore Resources and former Head of Westpac Institutional Banking. Insights shared on the panel discussion demonstrate that more banks are extending lending targets to help business transition; greenwashing can now be a finable offense; and the return of investment in ESG-related funds continues to rise. The event was well-attended by over 80 guests, UNAAWA members and community partners and concluded with a vibrant networking session.







#### SDG Forum 2: Future Leaders Development - Sports for Children & Achieving SDGs

The SDG Forum on 3 August marked the third anniversary of our partnership with West Coast Eagles in the promotion of the SDG goals in our community. The forum explored the role sports can play in achieving positive development of children and achievement of the UN Sustainable Development Goals (SDGs) – Good Healthy & Wellbeing, Zero Poverty, Quality Education, and Sustainable Communities. Attendees had fun with the live quizzes and were engaged in interacting with amazing panellists. Speakers include Peter Whittaker, the CFO of the West Coast Eagles, Michael Roberts, CEO of West Australian Football Commission, Tore Nelson, a Naitanui Academy player, Jackson Nelson, Captain of the WAFL Eagles, and Dr Victoria Absalom-Hornby, Partnership Lead of the Valuing Children Initiatives and a UNAAWA community partner. I had the pleasure of chairing the panel session where our speakers shared insights on how sports can help achieve the Sustainable Development Goals and transform social and educational objectives. Sponsored by BHP, the forum was well-attended by the Mayor of Victoria Park, series sponsor, athletes of Special Olympics, high school students, educators, UNAAWA members and community partners.





#### **Inaugural WAWeb3 for Sustainability Conference**

The SDG Business Forum team was instrumental in supporting the inaugural Web3 Conference at the University of Western Australia in March earlier this year. The event featured international speakers from diverse backgrounds highlighting ideas and opportunities that would help achieve the UN SDG Goals in an open, transparent, decentralized, and scalable way. Coorganised with the City of Nedlands, University of Western Australia and the Global Fintech





Institute, the panel sessions revealed that in order for Web3 to fulfill its promises, an intentional goal of inclusivity must be considered to represent all sectors, peoples and communities. The event was well attended by UNAAWA members, and we thank our community partners – school members, City of Nedlands, Curtin University, ASEAN Business Alliance and WA-Singapore Business Council for supporting the event.



#### 11th United Nations Business and Human Rights Forum at the United Nations HQ

In late November 2022, I had the pleasure of attending the 11th United Nations Business & Human Rights Forum at UNHQ in Geneva. It is the world's largest annual gathering on business and human rights with more than 2,000 participants from government, private sector, civil society, international organisations, trade unions, academia and media.

Following the attendance of the Forum, I was invited to participate in the development of educational curriculum on Labour Rights for the fishing industry and bear witness in the signing of the first MOU between the International Labour Organisation (ILO), Geneva School of Economics and Management - UNIGE, and the Global Business School Network (GBSN). This groundbreaking initiative was presided by the Manuela Tomei, ILO Assistant Director General for Governance, Rights and Dialogue; Professor Michael Posner, former Assistant Secretary of State for Democracy, Human Rights, and Labor on the Obama Administration, and Dan LeClair, CEO of GBSN.



#### 111th International Labour Conference at the United Nations HQ

I had the pleasure of sharing insights at the Future of Work Summit hosted by the TASC Platform of the Geneva Graduate Institute in June. The Summit took place alongside the tripartite negotiations of the 111th Session of the International Labour Conference (ILC) at the





United Nations. Convened by the World Economic Forum (WEF), a breakout session had experts from the Geneva Graduate Institute, WTO, International Labour Organisation (ILO), UNODC, UNRISD, Global Labour Justice and Nestlé shared insights on "Just-Transitions: What Role for Trade Policy". In addition, I also participated at a panel session which featured Professor Richard Baldwin of International Economics, and Janine Berg, Senior Economist of the ILO on "Social Protection: Preparing for the Age of AI". It was noted that ethical and responsible use of AI, in addition to investment in data governance, infrastructure and regulations, are crucial to the protection of workers and consumers. Interpretation and implementation of AI technologies & governance frameworks are highly influenced by culture and geographic variation. Therefore, inclusive AI development is critical so that no one is left behind.



#### **World Indigenous Tourism Summit 2023**

Western Australia hosts the country's first World Indigenous Tourism Summit (WITS) on 13-16 March with over 500 delegates participating at the 4-day event covering inspiring discussions on growing Indigenous Tourism in respective nations. As the Founding Chair of the SDG Forum and the former Board Director of the WA Indigenous Tourism Council (WAITOC), I had the pleasure of presenting at the summit on "Achieving the UN SDGs: A Collaborative Opportunity for Indigenous Tourism". I shared insights on the contribution of indigenous tourism with a panel of experts chaired by Professor Cheryl Kickett-Tucker AM of Curtin University of Technology.

As highlighted at the UNAAWA SDG Forum in 2019 "Indigenous & Eco-Tourism for the Achievement of the SDGs", it is essential to recognise the crucial role indigenous tourism play in job creation, promoting local economy, and educating us and future generation about our planet. It is essential to encourage further investment in research, training and media to support the custodians of our land in the important work they do to achieve the 2030 Agenda.







#### **WA Business & Human Rights Roundtable**

In support of the International Labour Organisation (ILO) and Global Business School Network (GBSN) initiative on human rights in business, a roundtable was organised by the SDG Forum team and hosted by Chevron to explore opportunities in which the education institutions could play a critical role in the economic, social and environmental future of our planet and societies.

As the GSBN cluster lead for 'Leadership & Governance in the Extractives", the Chair led a discussion which included stakeholders from education, government and extractives sectors. The session helped identify challenges, opportunities and value propositions for all stakeholders to mainstream human rights in business education. More importantly, business leaders emphasised the need for collaboration, skill-building, and a comprehensive understanding of human rights in different organisational roles. By taking a proactive approach, future business professionals are not only equipped with the necessary expertise but also possess the right mindset to advocate for and safeguard human rights.



#### **Upcoming Forum**

The next SDG forum will be held in partnership with the UNAAWA Young Professionals on the 5 October at the Pawsey Computing Centre. The theme will be "Sustaining Earth and Beyond: Space Innovation and Achieving SDGs". The panel will include speakers from the Department of Jobs, Tourism, Science & Innovation, a former NASA scientist, an entrepreneur in the domain, and a scientist from the Curtin Radio Astronomy Centre.






#### UN Day 2023 – 78th Anniversary of the Founding of the United Nations
